## REVISED SCHEDULING ORDER REGARDING MOTION OF ZIMMERMAN, INC. TO DETERMINE ITS CLAIM IS NOT SUBJECT TO DEBTORS' DISCHARGE INJUNCTION

To promote the efficient and expeditious disposition of the *Motion of Zimmerman, Inc. to*Determine its Claim is not Subject to Debtors' Discharge Injunction [Docket No. 3336] (the "Zimmerman Motion") filed by Zimmerman, Inc. ("Zimmerman") the following schedule shall apply to the Zimmerman Motion:

## IT IS HEREBY ORDERED that:

- 1. This Order amends and replaces the Court's Scheduling Order Regarding Motion of Zimmerman, Inc. To Determine its Claim is Not Subject to Debtors' Discharge Injunction [Docket No. 3471] in all respects.
- 2. Zimmerman has identified its witness list and possible additional deponents; if the Reorganized Debtors intend to call any witnesses in support of their case-in chief, the Reorganized Debtors will identify such persons no later than February 24, 2023; the parties will work in good faith to schedule depositions at a time convenient for the parties and witnesses.

- 3. Zimmerman must file any amendment or supplement to the Zimmerman Motion on or before March 27, 2023.
- 4. The Reorganized Debtors or any other responding party must respond or object to the Zimmerman Motion on or before April 28, 2023 (any such response or objection, collectively, an "Objection").
- 5. Zimmerman may file a reply in further support of the Zimmerman Motion and in response to any Objection on or before May 12, 2023.
- 6. The Reorganized Debtors shall identify any rebuttal witnesses no later than one (1) week following the completion of the depositions of all of Zimmerman's witnesses. If necessary, the parties will work in good faith to schedule depositions at a time convenient for the parties and any rebuttal witnesses.
- 7. Parties shall exchange deposition designations and exhibit lists on or before May 17, 2023.
- 8. Parties shall exchange objections to deposition designations and exhibit lists on or before May 24, 2023.
- 9. The evidentiary hearing to consider the relief requested in the Zimmerman Motion will be held before the Court on May 31, 2023 at 10:00 a.m. (prevailing Eastern Time) (the "Hearing") or such other date and/or time as the Court directs or the parties may agree, subject to the Court's availability.
- 10. The parties reserve all rights to agree to or seek approval of any additional or further extensions to the deadlines herein.

11. The Court retains jurisdiction over this Order and the relief granted herein.
