FIRST SUPPLEMENTAL DECLARATION OF DAVID R. HILTY IN SUPPORT OF THE APPLICATION FOR AN ORDER AUTHORIZING THE EMPLOYMENT AND RETENTION OF HOULIHAN LOKEY CAPITAL, INC. AS INVESTMENT BANKER AND FINANCIAL ADVISOR FOR THE OFFICIAL COMMITTEE OF UNSECURED CREDITORS OF ARCAPITA BANK B.S.C.(c).

NUNC PRO TUNC TO APRIL 12, 2012

I, David R. Hilty, hereby declare as follows:

- 1. I am a Managing Director of Houlihan Lokey Capital, Inc. ("Houlihan Lokey"). I am duly authorized to make this Supplemental Declaration on behalf of Houlihan Lokey and submit this Supplemental Declaration in support of the application of the above-captioned Official Committee of Unsecured Creditors of Arcapita Bank B.S.C.(c) ("Committee") in these chapter 11 cases for authorization of the employment and retention of Houlihan Lokey as financial advisor and investment banker to the Committee at the expense of the Debtors' estates.
- 2. Unless otherwise stated in this Supplemental Declaration, I have personal knowledge of the facts set forth herein and, if called as a witness, I would testify thereto.
- 3. On June 12, 2012, the Committee filed an application to retain Houlihan Lokey as financial advisor and investment banker. In support of the application, Houlihan Lokey filed a declaration executed by the undersigned on behalf of Houlihan

Lokey in accordance with the Bankruptcy Code (the "Original Declaration"). On September 17, 2012, a final order was signed authorizing the retention and employment of Houlihan Lokey, nunc pro tunc to April 12, 2012.

- 4. Since the filing of the Original Declaration, Houlihan Lokey has continued to monitor client databases maintained with respect to Houlihan Lokey, to determine whether it has any relationships with the entities (individually, an "Original Interested Party" and collectively, the "Original Interested Parties") that were identified to Houlihan Lokey by the Debtors, as well as additional entities who have subsequently become involved in the chapter 11 cases referenced above (individually, an "Incremental Interested Party" and collectively, the "Incremental Interested Parties" and, together with the Original Interested Parties, the "Interested Parties"). The Incremental Interested Parties, which are listed on Schedule 1, include, among others:
 - a) members of the ad hoc group of \$1.1 billion syndicated murabaha facility creditors and their counsel and financial advisors; and
 - b) certain potential interested lenders under the contemplated exit financing facility.
- 5. The attached <u>Schedule 2</u> details the relationship check performed by Houlihan Lokey, and identifies any relationships discovered through such investigation that members of Houlihan Lokey have with any Interested Parties in these chapter 11 cases.
- 6. Except as may be otherwise set forth herein, to the best of my knowledge, Houlihan Lokey, its principals and professionals (i) are "disinterested persons" under section 101(14) of the Bankruptcy Code, as modified by section 1107(b), and (ii) do not hold or represent any interest adverse to the Debtors' estates.
