Arcapita Bank B.S.C.(c) ("*Arcapita Bank*") and certain of its subsidiaries, as debtors and debtors in possession (the "*Appellees*"), hereby designate the additional items set forth below, pursuant to Rule 8006 of the Federal Rules of Bankruptcy Procedure to be included in the record on appeal of this Court's (i) *Findings of Fact, Conclusions of Law, and Order Confirming the Second Amended Joint Plan of Reorganization of Arcapita Bank B.S.C.(c) and Related Debtors With Respect to Each Debtor Other Than Falcon Gas Storage Company, Inc.
