1. I am a senior managing director with FTI Consulting, Inc., together with its wholly owned subsidiaries, agents, independent contractors and employees ("FTI"), an international consulting firm. I submit this affidavit (the "Second Supplemental Affidavit") to supplement my prior affidavits that were submitted in connection with FTI's retention in these Chapter 11 cases. Unless otherwise noted, I have personal knowledge of the facts set forth herein.⁽¹⁾

2. On March 19, 2012, the Debtors commenced these cases by filing voluntary petitions for relief under Chapter 11 of the United States Bankruptcy Code.

3. On June 12, 2012, the Committee filed an application to retain FTI as its Financial Advisor (the "Application"). In support of the Application, I executed an affidavit on behalf of FTI in accordance with the applicable sections of the Bankruptcy Code (the "Original Affidavit"). On or about July 10, 2012, I submitted a supplemental affidavit to update the

disclosures made in the Original Affidavit (the "First Supplemental Affidavit") (1) Certain of the disclosures herein relate to matters within the personal knowledge of other professionals at FTI and are based on information provided by them.

4. As noted in the Original Affidavit, it is FTI's policy to update and expand its ongoing relationship search for additional parties in interest in an expedient manner. If any new material relevant facts or relationships are discovered or arise, FTI will promptly file a supplemental affidavit to update its disclosures made pursuant to Rule 2014(a) of the Federal Rules of Bankruptcy Procedure.

5. Since the filing of the First Supplemental Affidavit, the following has come to my attention:

> a) On September 28, 2012, a Verified Statement Pursuant to Bankruptcy Rule 2019 was filed on behalf of certain holders (the "Ad Hoc Group") of the \$1.1 billion unsecured Murabaha syndicated facility dated as of March 28, 2007, issued by Arcapita Bank B.S.C.(c). The following entities comprise the Ad Hoc Group: Silver Point Capital, Taconic Capital Advisors, and York Capital Management Global Advisors. Upon information and belief, FTI currently represents Silver Point Capital, Taconic Capital Advisors, and York Capital Management Global Advisors in matters wholly unrelated to the Debtors and these Chapter 11 cases.

6. Pursuant to the Order Authorizing Retention of FTI Consulting, Inc. As Financial Advisor For The Official Committee of Unsecured Creditors, FTI shall provide ten days' notice to the Debtors, the United States Trustee, and the Committee in connection with any increase in the hourly rates listed in the Application. Effective January 1, 2013 such hourly rates are as follows:
