SUPPLEMENTAL ORDER GRANTING THIRD OMNIBUS OBJECTION TO CLAIMS

(LATE FILED CLAIMS)

Upon the motion of the Plan Administrator appointed in these cases (the “Third Objection”)¹ for entry of an order pursuant to 11 U.S.C. § 502 and Rule 3007 of the Federal Rules of Bankruptcy Procedure expunging, and/or disallowing each of the proofs of claim listed on Exhibit A attached hereto, on the basis that they were untimely filed; and due and sufficient notice of the Third Objection having been provided (i) to the claimants listed on Exhibit A at the addresses set forth on the claimants’ respective proofs of claim, (ii) counsel for the Committee, and (iii) the Office of the United States Trustee; and the Court having jurisdiction to decide the Third Objection under 28 U.S.C. §§ 157(a)-(b) and 1334(b); and the Third Objection having previously come before the Court for a hearing held on April 23, 2015; and a prior Order having been entered by the Court on May 7, 2015 [Docket No. 1064], granting, in part, the Third Objection; and an Amended Order Granting Third Omnibus Objection to Claims having been thereafter entered by the Court on June 18, 2015 [Docket No. 1130]; and the Third Objection having been previously adjourned as to the Claim No. 863 (Roseann Santoro), Claim No. 1473 (Alaigh Care Associates), Claim No. 865 (Mariann Amann), Claim No. 870 (Derek Haskett),

Claim No. 862 (Victoria Koller), Claim No. 1010 (Marylu Lepore), and Eassaw Wade (Claim No. 1081); and an adjourned hearing having been held with respect to Claim No. 863 and Claim No. 1473 on June 16, 2015; (the "Hearing"); and upon the record made before the Court at the Hearing; and, after due deliberation, the Court having determined that the legal and factual basis set forth in the Third Objection establish sufficient cause for the relief granted herein, which is in the best interests of the Debtors and their estates, it is hereby

ORDERED, that the hearing on the Third Objection is ADJOURNED to August 4, 2015 at 10:00 a.m. as to the following claims:

- Mariann Amann (Claim No. 865)
- Derek Haskett (Claim No. 870)
- Victoria Koller (Claim No. 862)
- Marylu Lepore (Claim No. 1010)
- Eassaw Wade (Claim No. 1081); and it is further

ORDERED, that the relief requested in the Third Objection is WITHDRAWN as to Claim No. 863 (Roseann Santoro); and it is further:

ORDERED that the relief requested in the Third Objection is GRANTED as to Claim No. 1473 (Alaigh Care Associates), which claim is expunged and disallowed in its entirety as being untimely; and it is further

ORDERED, that the Debtors' claims and noticing agent, Garden City Group, LLC, and the Clerk of this Court are authorized to take any and all actions that are necessary or appropriate to give effect to this Order; and it is further

ORDERED, that this Court shall retain jurisdiction over any and all issues arising from
or related to the implementation and interpretation of this Order.
