ORDER GRANTING FOURTH OMNIBUS OBJECTION TO CLAIMS

Upon the fourth omnibus objection of the Plan Administrator appointed in these cases (the “Fourth Objection”)¹ seeking entry of an order, pursuant to 11 U.S.C. § 502 and Rule 3007 of the Federal Rules of Bankruptcy reclassifying, expunging, and/or disallowing each of the proofs of claim listed on Exhibit A attached hereto, on the basis that they were incorrectly classified; and due and sufficient notice of the Fourth Objection having been provided (i) to the claimants listed on Exhibit A at the addresses set forth on the claimants’ respective proofs of claim, (ii) counsel for the Committee, and (iii) the Office of the United States Trustee; and upon the responses to the Fourth Objection filed on behalf of Patricia Mastellone (Claim No. 1097), Ralph Oyague (Claim No. 1164), Michael Anthony Contracting Corp. (Claim No. 403) and Marcelle Harris (Claim No. 1162); and the Court having jurisdiction to decide the Fourth Objection under 28 U.S.C. §§ 157(a)-(b) and 1334(b); and upon the record of the hearing held by the Court on the Fourth Objection on August 4, 2015; and, after due deliberation, the Court having found and concluded that the legal and factual bases set forth in the Fourth Objection establish cause for the relief granted herein and that such relief is in the best interests of the

Debtors' estate, creditors and other parties in interest; and good and sufficient cause appearing, it is hereby

ORDERED, that the hearing on the relief requested in the Fourth Objection is ADJOURNED to October 21, 2015 at 10:00 a.m. as to the following claims:

- Soundview Management Associates (Claim No. 1065)
- Vjollca Gega (Claim No. 1188)
- New York Medical College (Claim No. 1178);

and it is further

ORDERED, that the relief requested in the Fourth Objection is GRANTED as to the remaining claims covered by the Fourth Objection as set forth on Exhibit A hereto, which claims are hereby reclassified, expunged and/or disallowed as set forth therein; and it is further

ORDERED, that the Debtors' claims and noticing agent, Garden City Group, LLC, and the Clerk of this Court are authorized to take any and all actions that are necessary or appropriate to give effect to this Order; and it is further

ORDERED, that this Order is deemed to be a separate order with respect to each claim covered hereby; and it is further

ORDERED, that this Court shall retain jurisdiction over any and all issues arising from or related to the implementation and interpretation of this Order.
