ORDER GRANTING SEVENTH OMNIBUS OBJECTION TO CLAIMS

ORDERED, that the relief requested in the Seventh Objection is ADJOURNED to October 21, 2015 at 10:00 a.m. as to the following claims:

- Rochelle Cheatham (Claim No. 1222)
- Lorna Brown (Claim No. 1224)
- NYS Attorney General Medicaid Fraud Control Unit (Claim No. 1271)
- NYS Department of Health (Claim No. 1294)
- NYS Department of Health (Claim No. 1295);

and it is further

ORDERED, that the relief requested in the Seventh Objection is GRANTED as to the remaining claims covered by the Seventh Objection, to the extent set forth below and upon the terms and conditions set forth herein; and it is further

ORDERED, that the Claims listed on Exhibit A, attached hereto, are hereby expunged and disallowed; and it is further

ORDERED, that the Debtors' claims and noticing agent, Garden City Group, LLC, and the Clerk of this Court are authorized to take any and all actions that are necessary or appropriate to give effect to this Order; and it is further

ORDERED, that this Order is deemed to be a separate order with respect to each claim covered hereby; and it is further

ORDERED, that this Court shall retain jurisdiction over any and all issues arising from or related to the implementation and interpretation of this Order.
