ORDER GRANTING TWENTIETH OMNIBUS OBJECTION TO CLAIMS

Upon the objection, dated June 16, 2017 (the “Twentieth Objection”),² of the Plan Administrator appointed in these cases seeking entry of an order pursuant to 11 U.S.C. § 502 and Rule 3007 of the Federal Rules of Bankruptcy Procedure disallowing and expunging each of the proofs of claim listed on Exhibit A attached to the Twentieth Objection on the basis that such claims are duplicative of proofs of claims listed on such Exhibit as “Surviving Claims”; and due and sufficient notice of the Twentieth Objection and the opportunity for a hearing thereon having been provided (i) on an individualized basis to the claimants listed on Exhibit A at the addresses set forth on the claimants’ respective proofs of claim, (ii) counsel for the Committee, and (iii) the Office of the United States Trustee; and no objections having been filed; and a certificate of no objection having been filed on July 19, 2017; and the Court having determined that no hearing is necessary pursuant to Local Bankruptcy Rule 9075-2; and, after due deliberation, the Court having determined that each of the claims at issue should be disallowed and expunged as a duplicate claim; and the Court having determined that the legal and factual basis set forth in the Twentieth Objection establish cause for the relief granted herein and that such relief is in the best interest of the Debtors’ estates, creditors and other parties in interest; and good and sufficient appearing, it is hereby

ORDERED, that the relief requested in the Twentieth Objection is GRANTED to the extent set forth below and upon the terms and conditions set forth herein; and it is further

ORDERED, that the Claims listed under the column entitled “Claims to be Expunged” on Exhibit A, as attached to the Twentieth Objection, are hereby disallowed and expunged and

each such Claim is survived by the respective claim listed under the column entitled “Surviving Claims”; and it is further

ORDERED, that the Debtors’ claims and noticing agent, Garden City Group, LLC., and the Clerk of this Court are authorized to take any and all actions that are necessary or appropriate to give effect to this Order; and it is further

ORDERED, that this Order is deemed to be a separate order with respect to each claim covered hereby; and it is further

ORDERED, that all rights of the Plan Administrator to object to any surviving claims against the Debtors, whether asserted or unasserted by any of the claimants affected by the Twentieth Objection, and to further object to the surviving claims on any other grounds discovered by the Plan Administrator during the pendency of this case, are hereby reserved; and it is further

ORDERED, that this Court shall retain jurisdiction over any and all issues arising from or related to the implementation and interpretation of this Order.
