SUPPLEMENT TO FIRST INTERIM FEE APPLICATION OF GIBSON, DUNN & CRUTCHER LLP

Gibson, Dunn & Crutcher LLP ("Gibson Dunn" or the "Firm"), co-counsel to Woodbridge Group of Companies, LLC and its affiliated debtors and debtors-in-possession in the above captioned chapter 11 cases (collectively, the "Debtors"), hereby supplements the *First Interim Fee Application of Gibson, Dunn & Crutcher LLP* [Docket No. 1677] (the "First Interim Fee Application") for the period from December 4, 2017 through February 28, 2018 (the "Application Period") by attaching, as Exhibit A through E hereto, certain schedules requested by the *Appendix B Guidelines for Reviewing Applications for Compensation and Reimbursement of Expenses Filed Under United States Code by Attorneys in Larger Chapter 11 Cases* (the "UST Guidelines"). In addition, Gibson Dunn respectfully states as follows to address the questions set forth under section C.5 of the UST Guidelines:

<u>UST Guidelines C.5(b)</u>:

Did you agree to any variation from, or alternatives to, your standard or customary billing rates, fees or terms for services pertaining to this engagement that were provided during the application period? If so, please explain.

The last four digits of Woodbridge Group of Companies, LLC's federal tax identification number are 3603. The mailing address for Woodbridge Group of Companies, LLC is 14140 Ventura Boulevard #302, Sherman Oaks, California 91423. Due to the large number of debtors in these cases, which are being jointly administered for procedural purposes only, a complete list of the Debtors, the last four digits of their federal tax identification numbers, and their addresses are not provided herein. A complete list of this information may be obtained on the website of the Debtors' noticing and claims agent at www.gardencitygroup.com/cases/WGC, or by contacting the undersigned counsel for the Debtors.

Gibson Dunn Response:

No. During the Application Period, Gibson Dunn did not agree to any variations from, or alternatives to, its standard or customary billing rates, fees, or terms.

UST Guidelines C.5(b):

If the fees sought in the fee application as compared to the fees budgeted for the time period covered by this fee application are higher by 10% or more, did you discuss the reasons for the variations with the client?

Gibson Dunn Response:

Gibson Dunn worked with the Debtors throughout the Application Period to assess and adjust the budget in light of case developments. The fees sought by Gibson Dunn in the First Interim Fee Application are not more than the fees budgeted by the Debtors for Gibson Dunn for the Application Period, as reflected in the Debtors' internal cash flow forecast.

<u>UST Guidelines C.5(c)</u>:

Have any of the professionals included in this fee application varied their hourly rate based on the geographic location of the bankruptcy case?

Gibson Dunn Response:

No. The professionals included in the First Interim Fee Application did not vary their hourly rate based on the geographic location of the bankruptcy case.

Does the fee application include time or fees related to reviewing or revising time records or preparing, reviewing, or revising invoices? (This is limited to work involved in preparing and editing billing records that would not be compensable outside of bankruptcy and does include reasonable fees preparing a fee application). Gibson Dunn Response:

No. The First Interim Fee Application did not include any fees dedicated to revising time records or preparing and revising invoices that would not normally be compensable outside of bankruptcy.

Gibson Dunn Response:

The time period covered by the First Interim Fee Application includes approximately 97.10 hours with a value of \$48,258.50 spent by Gibson Dunn to ensure that the time entries subject to the First Interim Fee Application comply with the Local Rules of Bankruptcy Practice and Procedure of the United States Bankruptcy Court for the District of Delaware and do not disclose privileged or confidential information. This review and any revisions associated therewith are a necessary component of Gibson Dunn's preparation of each monthly fee application.

EXHIBIT A

Customary and Comparable Compensation Disclosures

Voluntary Rate Disclosures

- The blended hourly rate for all Gibson Dunn timekeepers (including both professionals and paraprofessionals) who billed to non-bankruptcy matters (collectively, the "Non-Bankruptcy Matters")¹ during the 12-month period beginning on January 1, 2017 and ending on December 31, 2017 (the "Comparable Period") was in the aggregate, approximately \$769 per hour (the "Non-Bankruptcy Blended Hourly Rate").²
- The blended hourly rate for all Gibson Dunn timekeepers (including both professionals and paraprofessionals) who billed to the Debtors during the Application Period was approximately, **\$860**, per hour (the "<u>Debtor Blended Hourly Rate</u>").³
- A detailed comparison of these rates is as follows:

It is the nature of Gibson Dunn's practice that certain non-bankruptcy engagements require the advice and counsel of professionals and paraprofessionals who work primarily within Gibson Dunn's Restructuring Group. Accordingly, Non-Bankruptcy Matters consist of matter for which Gibson Dunn timekeepers represented a client in a matter other than an in-court bankruptcy proceeding. Moreover, the Non-Bankruptcy Matters include time billed by Gibson Dunn timekeepers who work primarily within Gibson Dunn's Restructuring Group.

The billing rate for each professional at Gibson Dunn is based on a number of factors, including seniority. Gibson Dunn does not charge a higher hourly rate for bankruptcy professionals as compared to non-bankruptcy professionals, and each bankruptcy professional's rate is the same whether he or she is billing time to a bankruptcy matter or a non-bankruptcy matter. The differential between the average Blended Hourly Rate in these cases and the average Non-Bankruptcy Blended Hourly Rate primarily reflects the fact that these cases have required a greater percentage of time from more senior attorneys as compared to other matters, including without limitation discovery-intensive litigation, that are factored into the Non-Bankruptcy Blended Hourly Rate.

- Gibson Dunn calculated the blended rate for Non-Bankruptcy Matters by dividing the *total dollar amount* billed by Gibson Dunn timekeepers to the Non-Bankruptcy Matters during the Comparable Period by the *total number of hours* billed by Gibson Dunn timekeepers to the Non-Bankruptcy Matters during the Comparable Period.
- Gibson Dunn calculated the blended rate for timekeepers who billed to the Debtors by dividing the *total dollar amount billed* by such timekeepers during the Application Period by the *total number of hours billed* by such timekeepers during the Application Period.
