# SUPPLEMENTAL NOTICE OF FORMATION OF AD HOC NOTEHOLDER GROUP PURSUANT TO JANUARY 23, 2018, ORDER [D.I. 357]

PLEASE TAKE NOTICE THAT, pursuant to the January 23, 2018, order of the Bankruptcy Court [D.I. 357] (the "January 23 Order") approving a settlement of, among other things, the motion of the Ad Hoc Committee of Holders of Promissory Notes of Woodbridge Mortgage Investment Fund Entities and Affiliates (the "<u>Movant Committee</u>") for appointment of an official committee of noteholders [D.I. 85], the Movant Committee formed an eight-member ad hoc group of noteholders (the "<u>Ad Hoc Noteholder Group</u>") on February 1, 2018 (the "<u>Formation Date</u>"). Notice of formation of the Ad Hoc Noteholder Group was filed on the docket on February 2, 2018 [D.I. 470]. Weiner was a member of the Movant Committee and its Executive Committee, and holds

\$4,150,760 in notes. Dr. Weiner did not act as a broker or financial advisor with respect to Woodbridge investment products, and does not have any "unit" holdings.

2. **Jane & Harry Breyer** – 7186 Arcadia Bay Court, Delray Beach, FL 33446. Ms. Breyer was a member of the Movant Committee and a Co-Chair of its Executive Committee, and holds \$50,000 in notes personally, and \$500,000 as attorney-in-fact for her mother, Lorraine Schocket. Mr. Breyer was a member of the Movant Committee and its Executive Committee, and holds \$2,600,000 in notes indirectly as beneficiary of the Harry Breyer Revocable Living Trust. Ms. Breyer and Mr. Breyer did not act as a broker or financial advisor with respect to Woodbridge investment products, and they do not have any "unit" holdings.

3. **Richard Carli** – 221 Ventasso Drive, Clayton, NC 27520. Mr. Carli was a member of the Movant Committee and a Co-Chair of its Executive Committee, and holds \$430,000 in notes personally (Traditional IRA), \$575,000 in notes jointly with Lois M. Carli, and \$70,000 in notes as attorney-in-fact for Lois M. Carli (Roth IRA). Mr. Carli did not act as a broker or financial advisor with respect to Woodbridge investment products, and does not have any "unit" holdings.

4. **Jay Beynon –** 531 East Maple Avenue, El Segundo, CA 90245. Mr. Beynon was a member of the Movant Committee and its Executive Committee, and holds \$500,000 in notes as trustee of the Jay Beynon Family Trust. Mr. Beynon did not act as a broker or financial advisor with respect to Woodbridge investment products, and does not have any "unit" holdings.

5. **Kathleen Washko** – 501 Rugby Place, Schaumberg, IL 60194. Ms. Washko was a member of the Movant Committee and holds a total of \$460,041 in notes (\$286,041 individually, \$130,000 jointly with Brian Washko, and \$44,000 jointly with Stephanie Washko).

Mr. Heidari did not act as a broker or financial advisor with respect to Woodbridge investment products, and does not have any "unit" holdings.

7. **Marc Fruchter** – 20 Rivoli Ln., Greenville, SC 29615. Mr. Fruchter is a member of the Joint Representation Group [*see* D.I. 216] and holds \$150,000 in notes. Mr. Fruchter did not act as a broker or financial advisor with respect to Woodbridge investment products, and does not have any "unit" holdings.

8. **David Ellingson** – 191 Harborview Ct., Ventura, CA 93003. Mr. Ellingson was a member of the Joinder Noteholder Group [*see* D.I. 197] and holds \$100,000 in notes. Mr. Ellingson did not act as a broker or financial advisor with respect to Woodbridge investment products, and does not have any "unit" holdings.

9. **Richard Doss –** 14 Trailwood Rd., Rancho Santa Margarita, CA 92688. Mr. Doss is a member of the Utah Noteholder Group [*see* D.I. 319] and holds \$60,000 in notes. Mr. Doss did not act as a broker or financial advisor with respect to Woodbridge investment products, and does not have any "unit" holdings.
