1. On April 13, 2018, FTI Consulting, Inc. (“FTI”), financial advisor to the Official Committee of Unsecured Creditors (the “Committee”) filed the *Second Monthly Fee Application of FTI Consulting, Inc., Financial Advisor to the Official Committee of Unsecured Creditors, for Allowance of Compensation for Services Rendered and Reimbursement of Expenses Incurred for the Period from January 1, 2018 through January 31, 2018* [Docket No. 1258] (the “Application”) with the United States Bankruptcy Court for the District of Delaware (the “Court”).

2. Pursuant to the notice of Application, objections were to be filed and served no later than 4:00 p.m. on May 3, 2018. The undersigned further certifies that he has reviewed the Court’s docket in this case and no answer, objection or other responsive pleading to the Application appears thereon.

Pursuant to the *Order Establishing Procedures for Interim Compensation and Reimbursement of Expenses of Professionals*, entered on January 9, 2018 [Docket No. 261] (the “Administrative Order”), as modified by the *Order Approving Fee Examiner and Establishing Related Procedures for the Review of Fee Applications of Retained Professionals*, entered on February 8, 2018 [Docket No. 525] (the “Fee Examiner Order”), the Debtors are authorized to pay FTI \$548,489.00 which represents 80% of the fees (\$685,611.25), and \$7,815.48, which represents 100% of the expenses, requested in the Application for the period January 1, 2018 through January 31, 2018, upon the filing of this certificate and without the need for entry of a Court order approving the Application.
