
1. I am a competent adult and am otherwise capable of making this sworn statement.



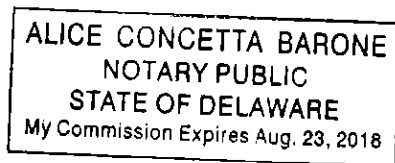

