**DECLARATION OF BRADLEY D. SHARP IN SUPPORT OF DEBTORS' MOTION TO
SELL 831 GRAND AVENUE, GLENWOOD SPRINGS, COLORADO PROPERTY**

I, Bradley D. Sharp, hereby declare under penalty of perjury, pursuant to section 1746 of title 28 of the United States Code, as follows:

1. I am President and CEO of Development Specialists, Inc. ("DSI"), located at 333 S. Grand Avenue Suite 4070, Los Angeles, California 90071, and the Chief Restructuring Officer of WGC Independent Manager LLC, a Delaware limited liability company ("WGC Independent Manager"), which is the sole manager of debtor Woodbridge Group of Companies, LLC, a Delaware limited liability company and an affiliate of each of the above-captioned debtors and debtors in possession (each, a "Debtor" and collectively, the "Debtors"). I submit this declaration (this "Declaration") in support of the *Debtors' Motion for Entry of an Order (I) Authorizing the Sale of 831 Grand Avenue, Glenwood Spring, Colorado Property Owned by the Debtors Free and Clear of Liens, Claims, Encumbrances, and Other Interests; (II) Approving the Related Purchase Agreement; and (III) Granting Related Relief* (the "Sale Motion").² All

facts set forth in this Declaration are based upon my personal knowledge of the Debtors' operations, information learned from my review of relevant documents, and discussions with the Debtors' professional advisors. I am authorized to submit this Declaration on behalf of the Debtors and, if called upon to testify, I could and would testify competently to the facts set forth herein.

2. Pursuant to the terms of the settlement approved by this Court on January 23, 2018 between the Debtors, the Official Committee of Unsecured Creditors, the Securities and Exchange Commission, the Ad Hoc Committee of Noteholders, and the Ad Hoc Committee of Unitholders (the "Settlement"), the Debtors' board of managers was reconstituted as a three-person board consisting of Richard Nevins, Freddie Reiss, and Michael Goldberg (collectively, the "Board") [D.I. 357-1]. On January 26, 2018, the Board approved my retention as the Debtors' new Chief Restructuring Officer. On February 13, 2018, the Court entered an order approving my retention as Chief Restructuring Officer [D.I. 573].

3. The Property is located at 831 Grand Avenue and consists of a vacant commercial building located on Lots 17, 18, and 19 and two adjacent parking lots situated on Lots 15 and 16. I understand that the Seller purchased the commercial building in August 2014 for a purchase price of \$1,200,000 and purchased the parking lots in September 2014 for an aggregate purchase price of \$333,333.

4. In consultation with the Debtors' other advisors, I have determined that selling the Property now on an "as is" basis at the price of \$1,100,000 best maximizes the value of the Property. The Property has been formally listed on the multiple-listing service and marketed by the Debtors at an asking price of \$1,200,000 since May 1, 2018. The Property was previously listed on the multiple-listing service at various times prior to the Petition Dates at higher asking prices, without success. During the current listing period, the Debtors received offers for the Property from two potential buyers (prior to the Purchaser's offer). Those offers were at

\$750,000 and \$800,000. The Debtors countered each of those offers at full asking price and received no response. The Purchaser's all cash offer under the Purchase Agreement is the highest and otherwise best offer the Debtors have received. Moreover, I, in consultation with the Debtors other advisors, have determined that the sale price is reasonable in comparison to comparable properties in the market in which the Property is located and in light of the fact that the commercial building is vacant and in need of serious repairs. Accordingly, I have determined that selling the Property on an "as is" basis to the Purchaser is the best way to maximize the value of the Property.

5. On June 25, 2018, the Purchaser made a \$1,100,000 all cash offer on the Property. The Debtors believe that this purchase price provides significant value and, accordingly, countersigned the final Purchase Agreement on June 29, 2018. Under the Purchase Agreement, the Purchaser agreed to purchase the Property for \$1,100,000, with a \$60,000 initial cash deposit, and the balance of \$1,040,000 to be paid in cash at closing.

6. To the best of my knowledge, (i) the Purchase Agreement was the product of good faith, arm's-length negotiations between the Purchaser and the Seller, (ii) the Purchaser is not related to or an affiliate of the Debtors or any of their insiders or former insiders, and (iii) no non-debtor affiliate or current or former officer, director, employee, managing member or affiliate of any of the Debtors (other than Seller) is a party to, or broker in connection with, the Sale.

Pursuant to 28 U.S.C. § 1746, I declare under penalty of perjury that the foregoing is true and correct to the best of my knowledge, information, and belief.
