Woodbridge Group of Companies, LLC and its affiliated debtors and debtors in possession (collectively, the "<u>Debtors</u>") in the above-captioned chapter 11 cases (the "<u>Chapter 11 Cases</u>") hereby file this objection (this "<u>Objection</u>"), pursuant to section 502 of title 11 of the United States Code, 11 U.S.C. §§ 101–1531 (the "<u>Bankruptcy Code</u>"), Rule 3007 of the Federal Rules of Bankruptcy Procedure (the "<u>Bankruptcy Rules</u>"), and Rules 3007-1 and 3007-2 of the Local Rules of Bankruptcy Practice and Procedure of the United States Bankruptcy Court for the District of Delaware (the "<u>Local Rules</u>"), to each of the claims filed against the Debtors and their estates that are listed on <u>Exhibit A</u> (collectively, the "<u>Disputed Claims</u>")<sup>2</sup> to the proposed form of

For the avoidance of doubt, the Debtors do not hereby object to any claims listed on <u>Exhibit A</u> to the Proposed Order that are identified under the heading titled "REMAINING CLAIMS" (collectively, the "<u>Remaining Claims</u>"), and the term "Disputed Claims" as used herein does not include any such Remaining Claims; provided, however, that the Debtors reserve all rights with respect to the Remaining Claims.

Order disallowing and expunging the Disputed Claims, as indicated in further detail below and on Exhibit A to the Proposed Order. In support of this Objection, the Debtors rely on the declaration of Bradley Sharp (the "Sharp Declaration"), a copy of which is attached hereto as Exhibit 1. In further support of this Objection, the Debtors respectfully represent as follows:

#### **JURISDICTION AND VENUE**

1. The Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 1334(b) and 157 and the *Amended Standing Order of Reference* from the United States District Court for the District of Delaware dated as of February 29, 2012. This is a core proceeding pursuant to 28 U.S.C. § 157(b) and, pursuant to Local Rule 9013-1(f), the Debtors consent to the entry of a final order by the Court in connection with this Objection to the extent that it is later determined that the Court, absent consent of the parties, cannot enter final orders or judgments in connection herewith consistent with Article III of the United States Constitution. Venue is proper before the Court pursuant to 28 U.S.C. §§ 1408 and 1409. The statutory and legal predicates for the relief requested herein are Bankruptcy Code section 502(b), Bankruptcy Rule 3007, and Local Rules 3007-1 and 3007-2.

#### GENERAL BACKGROUND

2. On December 4, 2017, 279 of the Debtors commenced voluntary cases under chapter 11 of the Bankruptcy Code, and on February 9, 2018, March 9, 2018, March 23, 2018, and March 27 2018, additional affiliated Debtors (27 in total) commenced voluntary cases under chapter 11 of the Bankruptcy Code (collectively, the "Petition Dates"). Pursuant to sections 1107(a) and 1108 of the Bankruptcy Code, the Debtors are continuing to manage their financial affairs as debtors in possession.

- 3. The Chapter 11 Cases are being jointly administered pursuant to Bankruptcy Rule 1015(b) and Local Rule 1015-1. No trustee or examiner has been appointed in the Chapter 11 Cases. An official committee of unsecured creditors (the "Committee") was appointed in the Chapter 11 Cases on December 14, 2017 [D.I. 79]. On January 23, 2018, the Court approved a settlement providing for the formation of an ad hoc noteholder group (the "Noteholder Group") and an ad hoc unitholder group (the "Unitholder Group") [D.I. 357].
- 4. Information about the Debtors' business, capital structure and the events leading up to the commencement of these Chapter 11 Cases is set forth in the *Disclosure Statement for the First Amended Joint Chapter 11 Plan of Liquidation of Woodbridge Group of Companies, LLC and its Affiliated Debtors* [D.I. 2398].

#### **DEBTORS' SCHEDULES; BAR DATE ORDER; AND PROOFS OF CLAIM**

- 5. On April 15 and 16, 2018, the Debtors filed their Schedules of Assets and Liabilities.
- 6. On December 5, 2017, the Court entered an order [D.I. 46] appointing Garden City Group, LLC ("GCG") as claims and noticing agent in these Chapter 11 Cases. Among other things, GCG is authorized to (a) receive, maintain, and record and otherwise administer the proofs of claim filed in these Chapter 11 Cases and (b) maintain the official claims register for the Debtors.
- 7. On April 5, 2018, the Court entered an order [D.I. 911] (the "Bar Date Order") establishing, *inter alia*, June 19, 2018 (the "Bar Date") as the general bar date for the filing of proofs of claim against the Debtors. On April 20, 2018, the Debtors filed the *Notice of Deadlines for Filing of Proofs of Claim and Proofs of Interest* [D.I. 1599] (the "Bar Date Notice"), pursuant to which the Debtors provided notice of, *inter alia*, the Bar Date. The

Debtors served the Bar Date Notice in accordance with the procedures set forth in the Bar Date Order. *See* D.I. 1688 (Affidavit of Service).

#### **RELIEF REQUESTED**

- 8. By this Objection, the Debtors request that the Court enter the Proposed Order, pursuant to section 502(b) of the Bankruptcy Code, Bankruptcy Rule 3007 and Local Rules 3007-1 and 3007-2, disallowing and expunging the Disputed Claims, as indicated in further detail below and on Exhibit A to the Proposed Order.
- 9. In accordance with Local Rule 3007-1(e)(i)(E), the Debtors believe that this Objection complies in all material respects with Local Rule 3007-1.

#### **OBJECTION TO DISPUTED CLAIMS**

10. Each of the Disputed Claims listed on Exhibit A to the Proposed Order under the heading titled "CLAIMS TO BE DISALLOWED & EXPUNGED" (collectively, the "Duplicative Claims") are duplicative of the proofs of claim listed under the heading titled "REMAINING CLAIMS" on Exhibit A to the Proposed Order. The Debtors believe that it was not the intention of the claimants asserting these multiple substantively identical claims to seek a double recovery against the Debtors' estates. Instead, the filing of the Duplicative Claims appears to be a function of the claimants filing multiple substantively identical proof of claim forms on account of a single claim, or filing the same claim with multiple parties (e.g., the claims and noticing agent in these Chapter 11 Cases, the Debtors, counsel to the Debtors, and/or the Clerk of the Court). Regardless of the claimants' reasons for filing the Duplicative Claims, at most, only one claim against the Debtors' estates should be allowed for each claimant. Any failure to disallow the Duplicative Claims will result in the applicable claimants potentially

For the avoidance of doubt, the Duplicative Claims to which the Debtors hereby object *do not* include claims filed against two or more different Debtors that are otherwise duplicative. *Cf.* Del. Bankr. L.R. 3007-1(d)(i).

receiving an unwarranted double recovery against the Debtors' estates, to the detriment of other creditors in these Chapter 11 Cases.

11. Accordingly, the Debtors object to the Duplicative Claims and request entry of the Proposed Order disallowing and expunging each of the Duplicative Claims.

#### **RESPONSES TO THIS OBJECTION**

12. Any responses to this Objection must be filed <u>on or before 4:00 p.m. (ET) on</u>

September 7, 2018, in accordance with the procedures set forth in the notice of this Objection.

#### **RESERVATION OF RIGHTS**

- 13. The Debtors reserve the right to adjourn the hearing on any Disputed Claim, and in the event that the Debtors do so, the Debtors will state the same in the agenda for the hearing on that Disputed Claim, which agenda will be served on the applicable claimant.
- 14. The Debtors and their estates reserve any and all rights to amend, supplement or otherwise modify this Objection, the Proposed Order, or Exhibit A thereto and to file additional objections to any and all claims filed in these Chapter 11 Cases, including, without limitation, any and all of the Disputed Claims and the Remaining Claims. The Debtors and their estates also reserve any and all rights, claims and defenses with respect to any and all of the Disputed Claims and the Remaining Claims, and nothing included in or omitted from this Objection, the Proposed Order, or Exhibit A thereto is intended or shall be deemed to impair, prejudice, waive or otherwise affect any rights, claims, or defenses of the Debtors and their estates with respect to the Disputed Claims and the Remaining Claims.

#### **NOTICE**

15. Notice of this Objection has been provided to the following parties: (i) the United States Trustee for the District of Delaware; (ii) counsel to the Committee; (iii) counsel to the

Noteholder Group; (iv) counsel to the Unitholder Group; (v) counsel to the DIP lender; (vi) all parties that, as of the filing of this Objection, have requested notice in these Chapter 11 Cases pursuant to Bankruptcy Rule 2002;<sup>4</sup> and (vii) claimants whose Disputed Claims are subject to this Objection. The Debtors submit that, in light of the nature of the relief requested, no other or further notice need be given.

#### **CONCLUSION**

WHEREFORE, for the reasons set forth herein, the Debtors respectfully request that the Court (a) enter the Proposed Order, and (b) grant such other and further relief as may be just and proper.

Any stay of this Order pending appeal by any of the claimants subject to this Order shall only apply to the contested matter which involves such claimant and shall not act to stay the applicability and/or finality of this Order with respect to the other contested matters covered hereby.
- 4. Garden City Group, Inc. is directed to modify the official claims register it maintains to comport with the relief granted by this Order.
- 5. Any and all rights of the Debtors and their estates to amend, supplement or otherwise modify the Objection and to file additional objections to any and all claims filed in these Chapter 11 Cases, including, without limitation, any and all of the Disputed Claims and the Remaining Claims, shall be reserved. Any and all rights, claims and defenses of the Debtors and their estates with respect to any and all of the Disputed Claims and the Remaining Claims shall be reserved, and nothing included in or omitted from the Objection is intended or shall be deemed to impair, prejudice, waive or otherwise affect any rights, claims, or defenses of the Debtors and their estates with respect to the Disputed Claims and the Remaining Claims.
