**STIPULATION REGARDING APPOINTMENT OF MEDIATOR**

Pursuant to this Court’s September 3, 2020, scheduling order (the “Scheduling Order”), plaintiff, Michael Goldberg, in his capacity as Liquidating Trustee of the Woodbridge Liquidation Trust, and defendants Chris Dantin Financial Services, LLC, and Chris A. Dantin Sr., stipulate as follows:

1. Derek C. Abbott, Esquire, of Morris, Nichols, Arsht & Tunnell LLP shall be appointed as the mediator (the “Mediator”) in this adversary proceeding.

2. The mediation between the parties shall proceed in accordance with the Scheduling Order and the deadlines set forth therein and shall be conducted in accordance with the Local Rules of Bankruptcy Practice and Procedure of the United States Bankruptcy Court for
