supplemented, or modified from time to time pursuant to the terms thereof, the "<u>Plan</u>"),² and the

Disclosure Statement for the First Amended Joint Chapter 11 Plan of Liquidation of Woodbridge

Group of Companies, LLC and its Affiliated Debtors [Docket No. 2398] (as it may be amended,

supplemented, or modified from time to time, the "Disclosure Statement"). The Disclosure

Statement was approved by the Court on August 22, 2018 [Docket No. 2396]. The Plan was

approved by the Court on October 26, 2018 [Docket No. 2903].

2. The Morrill Family Trust (the "<u>Claimant</u>" and, together with the Debtors, the

"<u>Parties</u>") is the Holder of a Class 3 Standard Note Claim (the "<u>Claim</u>").

3. The Debtors' Schedule of Principal Amounts and Prepetition Distributions lists the Claim as a Net Note Claim in the amount of \$4,833.43.

4. On its Class 3 Ballot, Claimant disputed the Net Note Claim amount set forth above, thereby becoming a Disputing Claimant under the Plan.

5. After conferring about the Prepetition Distributions received by Claimant and the calculation of Claimant's Claim, the Parties have entered into a stipulation (the "<u>Stipulation</u>"), pursuant to which the Parties agree that (i) the Claim shall be an Allowed Class 3 Standard Note Claim with a Net Note Claim amount of \$24,466.67, and (ii) Claimant shall be deemed to have elected not to become a Disputing Claimant on his Class 3 Ballot.³ A copy of the Stipulation is attached as Exhibit 1 to the proposed order approving the Stipulation (the "<u>Proposed Order</u>") attached hereto as <u>Exhibit A</u>. The Claimant has consented to the entry of the Proposed Order.

E. WHEREAS, the Debtors' Schedule of Principal Amounts and Prepetition Distributions, which is Schedule 3 to the Disclosure Statement, lists the Claim as a Net Note Claim in the amount of \$4,833.43;

F. WHEREAS, on its Class 3 Ballot, the Morrill Trust disputed the Net Note Claim amount set forth above, thereby becoming a Disputing Claimant under the Plan; and

G. **WHEREAS**, the Parties have conferred regarding the Prepetition Distributions received by the Morrill Trust and the calculation of the Morrill Trust's Class 3 Claim and have determined that the appropriate amount of the Morrill Trust's Net Note Claim is \$24,466.67.

NOW THEREFORE, the Parties agree as follows:

1. Recitals A through G, inclusive, are true and correct and are an integral part of this Stipulation.

2. The Claim shall be an Allowed Class 3 Standard Note Claim with a Net Note Claim amount of \$24,466.67.

3. The Morrill Trust shall be deemed to have elected not to become a Disputing Claimant on its Class 3 Ballot.
