(the “Administrative Order”), as modified by the *Order Approving Fee Examiner and Establishing Related Procedures for the Review of Fee Applications of Retained Professionals*, entered on February 8, 2018 [Docket No. 525] (the “Fee Examiner Order”), the Debtors are authorized to pay Berger \$3,654.40, which represents 80% of the fees (\$4,568.00), and \$62.50, which represents 100% of the expenses, requested in the Application for the period November 1, 2018 through November 30, 2018, upon the filing of this certificate and without the need for entry of a Court order approving the Application.
