**NOTICE OF NON-OPPOSITION TO ALAN BRILL'S REQUEST THAT THE COURT
ENTER AN ORDER PURSUANT TO FEDERAL RULE OF BANKRUPTCY
PROCEDURE 8002(d)(1) EXTENDING HIS TIME TO APPEAL**

On February 14, 2019, the Court entered an *Order Sustaining Debtors' Objection to Proofs of Claim filed by ERC I, LLC and Alan R. Brill* [Docket No. 3404] (the "Claim Objection Order") and an accompanying *Memorandum* [Docket No. 3403] (together with the Claim Objection Order, the "Claim Objection Ruling"). Pursuant to Rule 8002(a)(1) of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), the deadline to file a notice of appeal regarding the Claim Objection Ruling was February 28, 2019.

On March 13, 2019, Alan R. Brill ("Brill") filed the *Brill Motion that Court Accept His Attached Notice of Appeal, Granting Him Its Reasonable Acceptance Although Filed After the Standard 14-Day Requirement Due to Extenuating Circumstances* [Docket No. 3486] (the "Brill Filing"), which was docketed as a notice of appeal of the Claim Objection Ruling. In the Brill Filing, Brill asserts, among other things, that he was recently hospitalized and was suffering from

an illness and was therefore unable to timely file a notice of appeal from the Claim Objection Ruling.

In light of the representations made in the Brill Filing, and consistent with further discussions with Brill and review of documentation provided to counsel by Brill, the Woodbridge Liquidation Trust has no objection to the entry of an order pursuant to Bankruptcy Rule 8002(d)(1) extending Brill's deadline to file a notice of appeal of the Claim Objection Ruling through March 13, 2019, and deeming the Brill Filing a timely-filed notice of appeal.
