proper pursuant to 28 U.S.C. §§ 1408 and 1409; and this Court having found that this matter is a core proceeding pursuant to 28 U.S.C. § 157(b); and this Court having determined that it may enter a final order consistent with Article III of the United States Constitution; and this Court having found that notice of the Motion has been given as set forth in the Motion and that such notice is adequate and no other or further notice need be given; and a hearing having been held to consider the relief requested in the Motion; and upon the record of the hearing and all of the proceedings had before this Court; and this Court having found and determined that the relief sought in the Motion is in the best interests of the Debtors, their estates, their creditors and all other parties in interest; and that the legal and factual bases set forth in the Motion establish just cause for the relief granted herein; and this Court having previously entered (i) the Interim Order, Pursuant to Sections 105(a), 363(b), 503(b)(9), 1107(a), and 1108 of the Bankruptcy Code, Authorizing the Debtors to Pay Prepetition Claims of Critical Vendors, and Authorizing Banks to Honor and Process Checks and Electronic Transfer Requests Related to the Foregoing [Docket No. 48], and (ii) the Second Interim Order, Pursuant to Sections 105(a), 363(b), 503(b)(9), 1107(a), and 1108 of the Bankruptcy Code, Authorizing the Debtors to Pay Prepetition Claims of Critical Vendors, and Authorizing Banks to Honor and Process Checks and Electronic Transfer Requests Related to the Foregoing [Docket No. 295]; and after due deliberation and sufficient cause appearing therefor,

#### **IT IS HEREBY ORDERED THAT:**

1. The Motion is GRANTED, on a final basis, as set forth herein.

2. The Debtors are hereby authorized, but not directed, in their business judgment and at their sole discretion, to pay the Critical Vendor Claims in an aggregate amount not to

exceed \$1,500,000 unless otherwise ordered by the Court after notice and a hearing, provided

that:

- a. the Debtors shall provide the advisors to the Official Committee of Unsecured Creditors (the "<u>Committee</u>") with a list, which may be provided by electronic mail, of any Critical Vendor Claims sought to be paid (the "<u>Critical Vendor Claims List</u>"), which shall identify, without limitation, the following information: (i) the Debtor(s) against which the Critical Vendor Claim is asserted; (ii) the amount of the Critical Vendor Claim; (iii) the claimant asserting the Critical Vendor Claim; (iv) the basis for the Critical Vendor Claim, including the amount of such Critical Vendor Claim that is entitled to priority under section 503(b)(9) of the Bankruptcy Code and the amount that is a general unsecured claim; (v) whether the Debtors are providing a waiver under section 547 of the Bankruptcy Code; and (vi) any other information reasonably requested by the Committee;
- b. the Committee shall have through 5:00 p.m. prevailing Eastern Time on the second business day after receipt of the Critical Vendor Claims List to review the Critical Vendor Claims List (the "<u>List Review Period</u>") and notify the Debtors in writing, which may be by electronic mail, of any issues (the "<u>Issues</u>") with respect to the payment of any Critical Vendor Claim;
- c. if the Committee does not notify the Debtors of any Issues by the expiration of the List Review Period, or if the Committee consents to the proposed Critical Vendor Claims payments before expiration of the List Review Period, the Debtors shall be permitted to pay the respective Critical Vendor Claims, subject to the terms of this Order; and
- d. if the Committee timely notifies the Debtors of any Issue with respect to any Critical Vendor Claim payment (a "<u>Questioned Payment</u>") prior to the expiration of the List Review Period, then the Debtors shall not pay such Questioned Payment without further order of this Court or consent of the Committee; provided, however, that the Debtors may pay any other Critical Vendor Claim on the Critical Vendor Claims List other than any Questioned Payment.
- 3. The Debtors are authorized, but not directed, to condition the payment of Critical

Vendor Claims upon an agreement to continue supplying goods or services to the Debtors in

accordance with trade terms at least as favorable to the Debtors as those practices and programs

(including credit limits, pricing, timing of payments, availability, and other terms) in place prior

to the Petition Date (the "<u>Customary Trade Terms</u>"), or in the alternative to negotiate trade terms with any Critical Vendor or Critical Party, as a condition to payment, that vary from the Customary Trade Terms (the "<u>Negotiated Trade Terms</u>") to the extent the Debtors determine, in their reasonable business judgment, that such terms are necessary to procure essential goods or services or are otherwise in the best interests of the Debtors' estates.

4. The Debtors are authorized, but not directed, to condition the payment of Critical Vendor Claims upon such an agreement to continue supplying goods or services on Customary Trade Terms or Negotiated Trade Terms for the duration of the Chapter 11 Cases by executing trade agreements (each a "<u>Trade Agreement</u>"). Such Trade Agreements, once agreed to and accepted by a Critical Vendor or Critical Party, shall be legally binding contractual arrangements governing the commercial trade relationship between the parties as provided therein.

5. If a Critical Vendor or Critical Party accepts payment pursuant to this Order after agreeing to provide services on Customary Trade Terms or Negotiated Trade Terms, and thereafter does not continue to provide goods and services on such terms (regardless of whether a Trade Agreement has been executed), then (i) any payment on account of a Critical Vendor Claim may be deemed, in the Debtors' reasonable business judgment, to be an improper postpetition transfer and, therefore, recoverable by the Debtors in cash upon written request, and (ii) upon recovery of the payment by the Debtors, the Critical Vendor Claim shall be reinstated as if the payment had not been made. If there exists an outstanding postpetition balance due from the Debtors to a Critical Vendor or Critical Party, the Debtors may elect to recharacterize and apply any payment made pursuant to this Order to such outstanding postpetition balance, and the Debtors may then take any and all appropriate steps to cause such Critical Vendor or Critical Party to repay payments made to it on account of its prepetition claim to the extent that such

payments exceed the postpetition amounts then owing to such Critical Vendor and/or Critical party. Notwithstanding the foregoing, the Debtors' exercise of remedies pursuant to this paragraph is subject to entry of a further order, which the Debtors may seek by filing a motion to enforce the terms of this Order on not less than five (5) business days' notice to the affected counterparty.

6. The Bank is authorized, when requested by the Debtors, to receive, process, honor, and pay any and all checks drawn on, or electronic transfer requests from, their accounts, whether such checks or requests were presented or submitted prior to or after the Petition Date, to the extent such checks or requests are expressly identified by the Debtors as related directly to the payment of Critical Vendor Claims.

7. On the fifth (5th) business day of each month, the Debtors shall provide the Office of the United States Trustee, the DIP Lender, and the advisors to the Committee a report of all payments made under this Order.

8. Nothing in this Order (i) is intended or shall be deemed to constitute an assumption of any agreement pursuant to section 365 of the Bankruptcy Code or an admission as to the validity of any claim against the Debtors or their estates; (ii) shall impair, prejudice, waive, or otherwise affect the rights of the Debtors or their estates with respect to the validity, priority, or amount of any claim against the Debtors or their estates; (iii) shall impair, prejudice, waive, or otherwise affect the rights of the Debtors or their estates; (iii) shall impair, prejudice, waive, or otherwise affect the rights of the Debtors or their estates with respect to any and all claims or causes of action against a Critical Vendor or Critical Party; or (iv) shall be construed as a promise to pay a claim.

9. The Debtors are authorized to take any and all actions necessary to effectuate the relief granted herein.

Nothing in this Order (i) is intended or shall be deemed to constitute an assumption of any agreement pursuant to section 365 of the Bankruptcy Code or an admission as to the validity of any claim against the Debtors or their estates; (ii) shall impair, prejudice, waive, or otherwise affect the rights of the Debtors or their estates with respect to the validity, priority, or amount of any claim against the Debtors or their estates; (iii) shall impair, prejudice, waive, or otherwise affect the rights of the Debtors or their estates; (iii) shall impair, prejudice, waive, or otherwise affect the rights of the Debtors or their estates with respect to any and all claims or causes of action against a Critical Vendor or Critical Party; or (iv) shall be construed as a promise to pay a claim.

9. The Debtors are authorized to take any and all actions necessary to effectuate the relief granted herein.

10. Notwithstanding any applicability of Bankruptcy Rule 6004(h), the terms and conditions of this Order shall be effective and enforceable immediately upon its entry.
