Pursuant to the *Order Establishing Procedures for Interim Compensation and Reimbursement of Expenses of Professionals*, entered on January 9, 2018 [Docket No. 261] (the “Administrative Order”), as modified by the *Order Approving Fee Examiner and Establishing Related Procedures for the Review of Fee Applications of Retained Professionals*, entered on February 8, 2018 [Docket No. 525] (the “Fee Examiner Order”), the Debtors are authorized to pay PSZJ \$422,223.60, which represents 80% of the fees (\$527,779.50), and \$12,368.61, which represents 100% of the expenses, requested in the Application for the period December 14, 2017 through December 31, 2017, upon the filing of this certificate and without the need for entry of a Court order approving the Application.
