1. I am a principal with the firm of Province, Inc. ("<u>Province</u>"), which is an

operational and financial advisory firm with its principal office located at 2360 Corporate Circle,

Suite 330, Henderson, Nevada 89074. Province also has offices in the Los Angeles and Miami

metro areas. I am duly authorized to make this declaration (the "Supplemental Declaration") on

behalf of Province.

2. I submit this Supplemental Declaration in support of the *Application for Entry of*

an Order, Pursuant to Section 327(a) of the Bankruptcy Code, Authorizing the Employment and

Retention of Province, Inc. as Operational and Financial Advisors to the Debtors Nunc Pro Tunc

to February 1, 2018 [D.I. 692] (the "<u>Application</u>").² Except as otherwise noted,³ I have personal knowledge of the matters set forth herein and, if called as a witness, I could and would testify thereto.

3. In connection with the Debtors' proposed retention of Province, the United States Trustee has requested that I make the following disclosures:

- a. The Debtors previously retained Province to provide expert valuation services solely with respect to obtaining post-petition financing. Any additional services to be provided by Province were conditioned upon further court approval pursuant to a separate retention application. Order Pursuant to 11 U.S.C. §§ 105 and 363 Authorizing the Debtors to Retain Expert Consultant Nunc Pro Tunc as of December 18, 2017 [D.I. 360] (the "Valuation Services Order"). Consistent with the Valuation Services Order, Province now seeks retention as the operational and financial advisor to the Debtors pursuant to sections 327(a) and 328(a) of the Bankruptcy Code.
- b. The Debtors' current Chief Executive Officer, Frederick Chin, was previously employed by Province as a Senior Director from May of 2016 to January 28, 2018. Mr. Chin previously disclosed his former employment in the *Declaration of Frederick Chin in Support of Debtors' Motion under 105(a) and 363(b) for Authorization to Employ and Retain*
