PLEASE TAKE NOTICE that, pursuant to Fed. R. Civ. P. 26, 30 and 34, made applicable herein pursuant to Fed. R. Bankr. P. 7026, 7030, 7034, and 9014, the Official Committee of Unsecured Creditors appointed in the above-captioned cases (the "Committee") shall take discovery of Jorian L. Rose, Esq. in connection with the *Motion and Order for Admission Pro Hac Vice*, filed on March 28, 2018 [Docket No. 851], as set forth herein.

A. DEPOSITION NOTICE

The Committee will take the deposition upon oral examination of Jorian L. Rose, commencing at **2:00 p.m. Eastern time on April 4, 2018**. The deposition will take place at the offices of Pachulski Stang Ziehl & Jones LLP, 780 Third Avenue, New York, New York 10017. The deposition by oral examination will be taken before a notary public or an officer authorized by law to administer oaths upon oral examination, and will be recorded by a certified court

reporter by stenographic method through the use of real-time or otherwise, and/or by audio or video recording.

B. DOCUMENT REQUESTS

The Committee requests that Jorian L. Rose produce legible copies of the documents requested herein no later than **2:00 p.m. Eastern time on April 4, 2018**, or on such other date as may be agreed to by counsel, to **Pachulski Stang Ziehl & Jones LLP, 780 Third Avenue, 34th Floor, New York, New York 10017, Attn: John A. Morris.**

INSTRUCTIONS AND DEFINITIONS

- A. The use of the singular form of any word includes the plural, and vice versa.
- B. The connectives “and” and “or” shall be construed either disjunctively or conjunctively as necessary to bring within the scope of the discovery request all responses that might otherwise be construed to be outside of its scope.
- C. You are required to produce the full and complete originals, or copies if the originals are unavailable, of each Document responsive to the categories below along with all non-identical copies and drafts in its or their entirety, without abbreviations, excerpts, or redactions. Copies may be produced in lieu of originals if the entirety (front and back where appropriate) of the Document is reproduced and the Responding Party or its authorized agent or representative states by declaration or affidavit under penalty of perjury that the copies provided are true, correct, complete, and an accurate duplication of the original(s).
- D. If You withhold or redact a portion of any document under a claim of privilege or other protection, each such Document must be identified on a privilege log, which shall be produced contemporaneously with the non-privileged Documents responsive to this Request for Production, and which privilege log shall identify the following information:

1. The date of the Document;
 2. The type of Document (*e.g.*, letter, memorandum, report, etc.);
 3. The general subject matter of the Document;
 4. The name, address, telephone number and title of the author(s) of the Document;
 5. The name, address, telephone number and title of each recipient and/or addressee of the Document;
 6. The number of pages in the Document;
 7. The Document control number, if any;
 8. The present location(s) of the Document and the name, address and telephone number of the person(s) who has (have) possession of the Document;
 9. A general description of the subject matter of the Document or the portion redacted without disclosing the asserted privileged or protected communication;
 10. The specific privilege(s) or protection(s) that You contend applies.
- E. Unless otherwise indicated, the Documents requested include all documents that have come into existence or been utilized, read, transcribed, copied, placed in or retrieved from any file between December 4, 2017 and the date of Your response.
- F. “All” shall be construed as “all,” “any,” and “each.”
- G. “Cases” means the above-captioned bankruptcy proceedings, which are jointly administered at Case No. 17-12560 (KJC).
- H. “Communications” means the transmittal of information (in the form of facts, ideas, inquiries, or otherwise) and includes, without limitation, all written Communications of any nature, type or kind including, but not limited to, any Documents, telephone

conversations, discussions, meetings, facsimiles, e-mails, pagers, memoranda, and any other medium through which any information is conveyed or transmitted.

I. “Concerning” means relating to, referring to, describing, evidencing, or constituting.

J. “Debtors” means the above-captioned debtors and their affiliates listed in footnote 1 above.

K. “Document” is used herein in the broadest possible sense as specified in and interpreted under Rule 34 of the Federal Rules of Civil Procedure, and includes, without limitation, all originals and copies, duplicates, drafts, and recordings of any written, graphic or otherwise recorded matter, however produced, reproduced, or stored, and all “writings” as defined in Rule 1001 of the Federal Rules of Evidence, and all other tangible things by which human communication is transmitted or stored, meaning any kind of printed, recorded, graphic, or photographic matter, however printed, produced, reproduced, copies, reproductions, facsimiles, drafts and both sides thereof, including without limitation any kind of written, typewritten, graphic, photographic, printed, taped or recorded material whatsoever.

L. “Each” shall be construed as “all” and “each.”

M. “Motion” means the *Motion and Order for Admission Pro Hac Vice*, filed on March 28, 2018 [Docket No. 851].

N. “You,” “Your,” and “Yours” means and refers to Jorian L. Rose, Esq. and all persons and entities acting on behalf or for the benefit of Jorian L. Rose, Esq.

O. “Co-counsel” means any person, including any lawyer or law firm, who either You or any of Your clients in the Cases have engaged to represent any clients in the Cases.
